Why am I getting this notice?

- To inform you that reductions in coverage have been made to your policy. These and other changes outlined in this notice will go into effect on the renewal date of your policy, March 25, 2024.
 - We provide an Explanation of Changes in the following pages. Minor changes are not included. If there is a difference in your policy and this information, your policy will govern.
- To inform you of a new coverage option.
 - Your policy currently provides coverage when hail causes damage to metal gutters, downspouts, windows, doors, soffit, fascia, and eaves.
 - To provide you with choices and to customize coverage to better meet your needs, your policy will no longer provide coverage for cosmetic damage to these metal items caused by hail.
 - Hail damage to these metal items is considered cosmetic when it does not make a hole or opening in these metal items. The hail damage is to the metal surface only such as dents, indentations, or scratches.
 - If the hail does make a hole or opening in any of these metal items, your policy will provide coverage to repair or replace it.
 - You have a choice to purchase coverage for cosmetic damage to metal gutters, downspouts, windows, doors, soffit, fascia, and eaves caused by hail.
 - The cost for this coverage varies by state.
 - · Eligibility rules may apply.

What steps do I need to take?

- If you want cosmetic hail damage coverage for metal gutters, downspouts, windows, doors, soffit, fascia, and eaves on your home or other structures:
